## **Engaged Faculty Fellows Awards 2024-2025**

The Office of Civic and Community Engagement is pleased to announce the 2024-2025 Engaged Faculty Fellows Award Program. Our Office will award summer stipends of \$2,500 each to faculty who commit to creating courses that incorporate a significant component of civic engagement and community-engaged learning into the course curriculum. Proposed courses must meet the criteria established for Community-Engaged Learning courses at the University of Miami. These are courses that link the classroom and community through hands-on, experiential education that is transformative. They should:

- 1. Promote the interrelationship of teaching, research, and service through theory, action and reflection in response to community needs.
- 2. Develop and translate academic knowledge, critical thinking, and community engagement into civic responsibility.
- 3. Foster mutually beneficial collaborations between the university and the community to promote positive social change.
- 4. Incorporate reflection on the relationship between the community-based component and academic coursework into the course curriculum
- 5. Outline service-learning objectives in the student learning outcomes

The course can be an existing one that is refashioned to include a community-engaged learning component or an entirely new course. Recipients of the award must commit to teaching the class at least three times over the next five years. Faculty will participate in a workshop series that introduces them to key concepts and practices in civic engagement and community-engaged learning, and also will take part in a follow-up panel discussion about their experiences in developing the syllabi and teaching the courses. The Engaged Faculty Fellows Award Program is open to full-time University faculty who are engaged in undergraduate teaching. We strongly encourage faculty who participate in the EFF Program to make their EFF courses open to all students regardless of the student's College or School.

Criteria for selection include: school and departmental support; previous exposure and experience with and/or interest in learning about civic engagement and community-based learning; commitment to faculty development; high level of interest in the program; openness to collegiality and exchange of new ideas; potential contributions to the community; high level of interest in developing, implementing and sustaining innovative techniques to enhance teaching and learning.
